- Set-up: Thursday, January 12: 5 - 7 PM or Friday, January 14: 9-11:30 AM
  - You will need to provide your own table and chairs
  - Tear down will begin at 4 p.m. Sunday
- Vendors must be present all 3 days
- Parking: Once unloaded vendors must move their vehicles to the County Parking Garage on Fairview St.
- If accepted, you will receive an email; we accept vendors on a rolling basis until the spaces are full
